How to apply – 3 cases

1 - You don't need a visa

• You simply apply through our Applying Platform. Ex: European countries



2- You need a visa & your country of residence is part of the « Etudes en France » procedure

- You have to conduct two procedures in parallel
- The two procedures are independent
 1/ our Applying Platform + 2/ Etudes en France



3 - You need a visa & your country of residence is not listed for « Etude en France » procedures

- You simply apply through our Applying Platform
- If application is successful, you receive our Acceptance Letter to help you apply for the student visa procedure
- You check the information from the nearest French embassy or consulate in your country










A SINGLE ONLINE SERVICE FOR ALL PROCEDURES










« Applying » platform – application flow
