La Gacilly is a picturesque village and home to the leading French franchise, Yves Rocher. This well-known name in cosmetics has been based in the heart of the village since 1930. What was once a small family business has grown to become a large international brand. Its core mission is: "to make plant-based cosmetics[®], healthy, natural and environmentally friendly products, accessible to all women". Whilst the Yves Rocher Group comprises several brands, the core Yves Rocher brand was launched in 1959, and has been franchised since the late 1960s. They have more than 680 stores in France, and 2,899 in the world (https://groupe-rocher.com/marques/yves-rocher).

The village is home to its production facilities, botanical garden, an ecological hotel-spa, and, since 2017, the Maison Yves Rocher (Yves Rocher Museum). Around 30 craftspeople have opened workshops in the narrow streets of the village (<u>https://www.brittanytourism.com/destinations/the-10-destinations/destination-broceliande/la-gacilly/</u>).

Our trip will coincide with the 20th La Gacilly Photo Festival. This annual exhibition (for which Yves Rocher is one of the main sponsors) comprises approximately 20 open air galleries and provides an immersive photographic experience, where the photographers seek to explore our relationship with our world and our natural environment (https://www.festivalphoto-lagacilly.com/en/la-gacilly-photo-festival)
